Evaluation Methods Used: Conformance is evaluated through a combination of manual expert auditing and automated checks including:

- Screen reader testing with VoiceOver across Chrome/Firefox/Safari
- Chrome and Firefox DevTools accessibility tree analysis and contrast checks
- axe DevTools browser extension scans

- Keyboard-only navigation checks
- Deque axe-core testing engine integration in our development pipeline
- AI-powered analysis of our live product as users experience it in the browser, with expert validation of all findings
